STUD SERVICE AGREEMENT

TERMS:

1. The owner of the Bitch ("Owner") will provide the stud owner (24k Retrievers) a copy of the following items:

a) OFA rating

b) Eye report within 12 months (from a board certified ophthalmologist)

c) SAS Heart Clearance

d) 3 generation pediaree

e) Photograph of the Bitch

1. The Bitch's Owner is to coordinate the breeding with the stud dog owner. ALL expenses related to semen collection are the responsibilities of the Bitch's Owner. These monies are due at the time the breeding takes place. all transportation and veterinary expenses are to be paid by the Bitch's Owner.

2. The Bitch's Owner will be responsible for all veterinary fees related to the Bitch's breeding, care (smears, artificial inseminations, health certificates, etc.)

3. The Stud Fee is \$1800 and is subject to change prior to this contract being signed. A deposit of \$300 is due at the time this contract is signed. Three or more live puppies constitute a litter. If no litter results from this mating, or less than 3 live puppies are alive at 1 week of age then, no further payment will be due to 24k Retrievers and there are no further obligations on the part of either Party. If the Owner would like a repeat service then an additional deposit of \$300 will be due at the time of the breeding. This repeat breeding must be used within a year of the contract signing date. Both deposits will be applied to the original stud fee. A substitute Bitch may be used if all of the above conditions have been met and the substitute Bitch is acceptable to 24k Retrievers. If the repeat breeding is to be performed on the original Bitch, then this breeding must be done with progesterone and/or LH testing to help insure the exact breeding dates. Should no litter result from either of the two services, or should the Owner choose not to return for a second service, any monies paid will be nonrefundable, and no further fees will be due to 24k Retrievers.

4. Artificial Insemination/TCI

Artificial inseminations/TCI are performed by a veterinarian at the Bitch Owner's expense. It will be necessary to sign the following release. I request that any Artificial Inseminations be done by the Stud Dog Owners Veterinarian and understand that these are being performed at my expense and payable prior to the bitch's return.

5. Frozen Semen:

If frozen semen is to be used then there will be a charge of \$100.00 / per breeding unit plus ALL the expenses involved in shipping the semen. These fees are due in advance of the breeding.

The Stud Dog owner must be notified in advance to make any arrangements for these types of breedings.

6. The owner of the stud shall sign the litter registration application upon proper evidence of birth of the litter; but not earlier than 10 days, nor later than 8 weeks after whelp. A \$50 late fee will be incurred if the registration papers and balance of the Stud Fee arrive after the puppies are 3 weeks of age.

7. The Owner agrees, in registering the litter, to check the AKC's limited registration box for all puppies from this breeding being sold as pets. In addition, the Owner shall provide 24kRetrievers with a list of names, email address, phone numbers, and addresses of all puppy buyers.
